

# 24th International Congress of Young Medical Scientists

## REGULATIONS FOR ON-LINE INTERNATIONAL PARTICIPANTS

Poznań, 16-18 May 2024

### §1. General regulations

1. The 24th International Congress of Young Medical Scientists, further named the Congress, is a forum for exchanging knowledge and scientific experience and competition among the best scientific papers of students and young medical scientists.
2. The Congress will be held from the 16th to the 18th of May 2024. Original Paper Sessions will be held on the 17th of May, while Case Report Sessions, Poster Session, and Golden Session - on the 18th of May.
3. The Conference is organized by the Students' Scientific Society of Poznań University of Medical Sciences (from now on referred to as STN).
4. Concerning the participation in the Congress, the general regulations apply. These are formulated in a separate document, while this file presents exceptions that should be obeyed by international participants who will participate in the Congress online.
5. **An international participant is a student who studies abroad, at a University outside Poland. English Division students at Polish Universities are not regarded as international and therefore should take part in the Congress in person.**
6. **International active participants can attend the Congress online. Therefore, the Congress will be held in hybrid form.**
7. **Polish students who are currently studying abroad thanks to the Erasmus+ Program can participate in online form but are obliged to justify this decision by submitting a supporting document.**
8. We encourage all interested international students to take part in the Congress in person and therefore have the whole experience.
9. All other §1. General regulations apply as in the original document.

### §2. Abstract guidelines

1. All general regulations concerning abstracts apply to international participants.

### §3. Principles and forms of presentations

1. The general rules describing principles and forms of presentations apply to online participants.
2. The platform used for the online part of each session is ClickMeeting.
3. All online participants will be sent a link to the session.

4. The online part of the session will take place AFTER the presentations of all on-site participants. There is no need to log in before the live session starts, however, we advise you to log in earlier to the Session Room.
5. The Organizers are not responsible for any problems from the participant side, in particular an internet connection or other technical issues.
6. The presenting author is obligated to be alone in his/her room. Any other person cannot physically stay or enter the room in which the presenting person is staying during the time of presentation, discussion, and in between. The participant may not receive any assistance from other individuals. The participant must be always ready to present their whole room to the jury.
7. The presenting person must be equipped with a computer/tablet with an operable camera and microphone. **The camera should show the view of the participant including the whole face and upper limbs.** The presenting person is not allowed to move out from the camera view and mute the microphone during the whole time of presentation, discussion, and the time between presentation and discussion.
8. The participant must agree to be recorded during the Congress.
9. In cases where cheating is suspected, the Organizer is allowed to review the footage of the session and decertify the cheater.
10. **In case the presentation transmission is interrupted and less than 60% of the given time has passed, the participant is allowed to come out again at the end of the current session. If more than 60% of the given time has passed, the presentation is evaluated and the participant is not allowed to answer the questions at the end of the current session.**

## §4. Terms of competition during the Conference

1. The general rules describing terms of competition during the Conference apply to online participants.

## §5. Golden Session

1. **Participation in the Golden Session is required to be on-site.**
2. The general rules apply to the conduct of the Golden Session.

## §6. Registration and Fees

1. All general rules concerning Registration and Fees apply as stated in the general regulations.
2. **We accept only active online participants. There will not be any video live transmission for interested passive participants.**

## §7. Participation: possibilities and rules

1. All general rules concerning participation apply as stated in the general regulations except the below-mentioned points.
2. Active online participants should choose the “**Active**” type of participation and pay the specified fee.
3. Online participants **will not** be evaluated on their attendance at the workshops and/or keynote lectures. They will be given a certificate if they present their work abiding by the regulations of the participation.
